Privacy Policy

Protecting your private information is our priority: This Statement of Privacy applies to gfii.com and Greenfield Industries and governs data collection and usage. For purposes of this Privacy Policy, unless otherwise noted, all references to Greenfield Industries include gfii.com and GFI. The GFI website is an ecommerce site. By using the GFI website, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Sharing Information with Third Parties

GFI does not sell, rent, or lease its customer lists to third parties.

GFI may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange deliveries. All such third parties are prohibited from using your personal information except to provide these services to GFI, and they are required to maintain the confidentiality of your information.

GFI may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law to comply with legal process served on GFI or the site; (b) protect and defend the rights or property of GFI; and/or (c) act under exigent circumstances to protect the personal safety of users of GFI, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by GFI. This information can include your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the GFI website.

Use of Cookies

The GFI website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. SSL Protocol

- Debug to identify and repair errors that impair existing intended functionality.
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided by the law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
